

**African American and American Indian Patients in Grace Church Branch,  
Second Division General Hospital,  
November 30, 1864 to April 29, 1865**

In the mid 1850s, members of Alexandria's two existing Episcopal churches formed a new congregation. Although their new church edifice, in the 200 block of South Patrick Street, took several years to complete, services commenced in the unfinished basement by the end of the decade. Bishop John Johns consecrated the new house of worship on October 7, 1860. Less than eight months later, federal troops occupied the city, and the pastor, Rev. D.F. Spriggs, and many of his flock fled south, some to join the Confederate

army.<sup>1</sup> The congregation was able to meet only occasionally in the early days of the war, re-establishing regular services in May 1862, services terminated a month later when the property was seized by the U.S. Army for use as a hospital.<sup>2</sup>

Alexandria General Hospital opened in July 1861, apparently first located in the Mansion House Hotel and expanded into other buildings as needed. It was reorganized into three divisions in September 1862. These included several churches which offered large, open interior spaces. The Second Division General Hospital comprised Washington Hall and McVeigh Hospitals, the [First] Baptist Church Hospital and its ward in the Lyceum, and Grace Church Hospital. When L'Ouverture Hospital opened in 1864, largely to treat African American troops, it subsumed the Baptist Church and Grace Church branches.<sup>3</sup> Grace Church treated only white soldiers until November 30, 1864, when those remaining were transferred to Sickel<sup>4</sup> Barracks General Hospital, and the first 43 black soldiers were admitted. Grace Church Hospital closed April 29, 1865 at the end of the war—it, St. Paul's Episcopal, and the Baptist Church were the last houses of worship turned over to their congregations by the federal army—and its ill and wounded were transferred to L'Ouverture Hospital. Eighty-five men were carried to L'Ouverture, suggesting that Grace Church had been overcrowded; Miller later gave its capacity as only 75 beds.<sup>5</sup>

The following information on African American soldiers, one black civilian, and at least two American Indian troops (\*) treated at Grace Church Hospital is taken from two patient registers (Volume 339 and 340) and morning reports (Volume 344) from the hospital retained in the National Archives and Records Administration, Record Group 94, Records of the Adjutant General's Office, Entry 544, Field Records of Hospitals, 1821-1912, Virginia. Most of the ill and wounded were admitted to the hospital on November 30 and December 6, 1864 and on March 6, 1865. This suggests that large numbers had arrived on transports, probably from City Point, on those dates. L'Ouverture Hospital had only a couple of admissions on the latter two dates, but 55 on November 30, 1864, only one fifth of whom were wounded or injured as opposed to ill. Of the 111 entries, 32 percent lack a diagnosis. Less than 12 percent were admitted for gunshot wounds.
